General

- Unauthorized persons are not permitted to enter the premises and entry of the premises is at entrants' own risk.
- The entire premises are under video surveillance for security and identification purposes.
- · Traffic regulations apply throughout the entire premises unless otherwise indicated.
- · Always strictly follow the instructions and directions of Rd4 personnel.
- · Wearing high-visibility clothing (safety vest or jacket) is mandatory.
- · Wearing safety shoes (S3) is mandatory for individuals performing tasks such as maintenance, loading and/or unloading, etc.
- · Safety shoes (S3) are mandatory for everyone outside the walkways.
- · Always keep escape routes clear.
- · Firefighting and safety equipment must always be accessible.
- The maximum allowed speed is 15 km/h.
- · Bicycles and mopeds are not allowed; park them in the designated area.
- The use of mobile phones in the vehicle is only allowed when the vehicle is stationary.
- · The use of mobile phones outdoors is only allowed on a footpath behind a guardrail.
- · The use of headphones or music earplugs is prohibited on the entire premises.
- It is forbidden to drive with an uncovered load (also on public roads).
- · The possession and use of alcoholic beverages, drugs, or medications that may affect judgment are prohibited.
- · Open fires are strictly prohibited.
- Smoking is only allowed in the designated area.
- · Rd4 accepts no liability for damage to or theft of personal belongings at the O&O location.

On arrival

Upon arrival, you must always report directly to the reception at the weighbridge (except for automated loading or unloading operations).

Weighing

A maximum of one vehicle is allowed on the weighbridge per weighing.

Loading and unloading

- · Loading and unloading of cargo/loads is done at your own risk.
- It is forbidden to unload asbestos (or similar) and/or chemical materials.
- · Loading and unloading must be done wearing clothing with long sleeves and long trousers.
- · Loaders / passengers must remain in the vehicle during loading and unloading.
- Securing the load must always be done at the designated area, using the special ladder or a hook from the ground.
- · Standing on the load is prohibited.
- · It is prohibited to collect and take away substances and/or products from the waste.
- The acceptance of waste materials is strictly in accordance with the acceptance terms and conditions of Rd4.

Walking on the Premises

- · Drivers may only leave their vehicle for necessary work on the vehicle and must stay with the vehicle.
- · Loaders / passengers must remain in the vehicle.
- · The yellow-marked walkways may only be used with the permission of the site manager (except for O&O employees).
- · Maintenance work on the premises may only be carried out with a work permit and with permission from the site manager.

In case of emergency

- Immediately notify your Rd4 contact person. Emergency number Rd4: 06-23 50 42 15.
- · Secure your work if possible.
- Follow the green emergency exit signs and go to the emergency assembly point.
- · Follow the instructions of emergency response personnel or firefighters precisely.
- · Our locations are equipped with an Automated External Defibrillator (AED). Ask an emergency responder for assistance.
