General

- Unauthorized persons are not permitted to enter the premises and entry of the premises is at entrants' own risk.
- Always strictly follow the directions and instructions of the Rd4 staff.
- Everyone should be clearly visible and recognisable, wearing high visibility clothing (vest or jacket) is therefore mandatory where indicated.
- For persons performing work activities such as loading/unloading cargo, it is also mandatory to wear safety shoes.
- Keep escape routes clear at all times.
- Fire extinguishers and safety equipment must be accessible at all times.
- The maximum permitted speed is 15 km/hour.
- Cyclists and moped riders must dismount. At headquarters, this is with the exception of the access road before the barrier and the large car park for employees.
- Driving Rd4-material (such as loading shovel, sorting crane, fork-lift truck and other vehicles) always have the right of way.
- Keep to the right, especially at points where visibility is limited.
- Overtaking other vehicles is done at your own risk.
- Cargo/load must be covered when it is being transported (even on public roads).
- Possession and use of alcoholic beverages, drugs or medicines that could affect judgement are prohibited.
- Open fires are strictly prohibited.
- Smoking is only allowed in the designated areas.

On arrival

Upon arrival, you must report in immediately.

Headquarters: at the barrier and reception

O&O: at the weighbridge reception desk

RSC: at the barrier

TSC: to one of the managers (if you know them) or at the office

Weighing

A maximum of one vehicle is allowed on the weighbridge per weighing.

Loading and unloading

- Loading and unloading of cargo/loads is done at your own risk.
- It is forbidden to dispose of asbestos (or similar substances) and/or chemical material.
- The cargo should always be covered at the designated area, via the special staircase or with the use of a hook when standing on ground.
- It is forbidden to stand on top of the cargo/load.
- It is forbidden to collect and remove substances and/or products from the waste.
- The acceptance of waste is subject to the acceptance conditions and requirements of Rd4.

In the halls

O&O and RSC: Unless otherwise indicated by your Rd4 contact person, walking is only permitted within the red, marked route.

TSC: The demarcation of the forklift zone is indicated with red lines. You may only enter this zone with an Rd4 employee who has received instructions that you may do so.

In case of emergency

- Notify your Rd4 contact person immediately.
- Follow the green emergency exit signs and go to the assembly point.
- You must strictly follow the instructions of the emergency services or fire service.
- An Automatic External Defibrillator (AED) is presented at our locations. Ask an Rd4 employee for assistance.
